

Police 2021 Budget Breakdown












Five Largest Categories – Percent of Total Crime




Group A Crime Rate (per 1000 residents)







SAM deployed from January 13th to 28th, 2022







- Most vehicles were stolen overnight from the owner's home (driveway or yard)

- Transport
- Profit

- Our cases would indicate the motive is transport & profit
- Arrestees often have long history of theft and drug addiction




Crime Prevention

- If you have a garage – use it
- Remove valuables from vehicles

- Consider an alarm system or steering wheel lock






